## Student Wellness and Success Funds & Disadvantaged Pupil Impact Aid Plan – SY2026 and SY2027

Ohio's districts and schools receive Disadvantaged Pupil Impact Aid and Student Wellness and Success Funds to fund initiatives to support wraparound services for Ohio's students. These vital services help students overcome obstacles to learning, accelerate learning and prepare for future success.

Toledo School for the Arts' SWSF and DPIA Plan will include the following:

- Spend at least 50% of Student Wellness and Success Funds on physical or mental health services.
- The plan for using Student Wellness and Success Funds and Disadvantaged Pupil Impact Aid will collaborate with New Concepts and Toledo Police Department.
- The Student Wellness and Success Fund and DPIA plan will be shared with the TSA Board of Directors and posted to our website within 30 days after development or amendment of the plan.
- The Director and/or Treasurer will report annually to DEW how the district spent Student Wellness and Success Funds and Disadvantaged Pupil Impact Aid.
- TSA will spend Student Wellness and Success Funds by the end of the next fiscal year after they are received. For funds received this fiscal year (FY26), they will be spent by June 30, 2027. Additionally, Student Wellness and Success Funds received in FY27 will be spent by June 30, 2028.
- [Ohio law](#) does not specify the timeline in which Disadvantaged Pupil Impact Aid must be spent, but our District will leverage these funds in a timely manner to support the critical needs of students.

Ohio law outlines the uses for [Disadvantaged Pupil Impact Aid](#) and [Student Wellness and Success Funds](#). For Fiscal Years 2026 and 2027, districts and schools are required to use funding to support the initiatives outlined by the Ohio Department of Education.

**Student Wellness and Success Funds** received by Toledo School for the Arts will be used to support the following initiatives during the 2026 and 2027 school years:

1. **Mental Health Services** – Continued employment of four (4) Guidance Counselors to provide mental health support to students including behavioral health services and recovery supports.
2. **School Safety Measures** – Continued employment of off-duty police officers for security before and after schools, as well as, after school programs.

**Disadvantaged Pupil Impact Aid Funds** will be spent for the following initiatives:

1. **Academic Intervention** – Credit Recovery services, homework center, student tutoring, extended instruction and after school programs to keep students engaged.
2. **School Safety Measures** – Continued employment of off-duty police officers for security before and after schools, as well as, after school programs.
3. **Physical Health Services** – Continued employment of a School Nurse to assess and treat students’ physical health needs throughout the day.

Administrators and staff members will review the plan yearly and adjust as necessary for the benefit of all students.
